- Currently, 1,800,000 individuals have joined the army of light. If just one-third of this army (594,000) brings two witnesses each, who also send notices, we'll reach 1,782,000 notices.
 - If one-third of these witnesses (392,040) bring two more witnesses each, resulting in additional notices, we'll total 2,566,080 notices sent.

To prepare for this monumental event, print and fill out a notice for every public servant you aim to instruct. Encourage fellow citizens to join you by teaming up with two like-minded individuals. Together, you'll send a powerful message to public servants, reminding them of their duty to uphold the Constitution.

Gather in diverse community spaces like churches, libraries, town squares, or taverns, ensuring representation from various backgrounds. Witness each other's messages as a symbol of solidarity and unity. Make copies of the original notices and safeguard them.

Let's set aside our differences and unite for the greater good. Our strength lies in unity, and together, we wield the power to effect change.

Step 2. Fill Out Lawful Notification of Corrective Action to Prevent Maladministration

- a. Fill out the "Certification of Service" section by listing the recipients of the notice. To identify the appropriate recipients, you can use the website: <https://www.270towin.com/elected-officials/>. Enter your location in the "Search by Address, Zip Code, or City" area to locate your representatives in both the United States Congress and your state legislature. At a minimum, please ensure you send a notice to your representative in the state legislature. Additionally, you have the option to send notices to any other officials, whether federal, state, or local, whom you deem relevant.

DESCRIPTION:

Join us in a historic nationwide campaign on April 24, 2024, where individuals across the country will unite to deliver a powerful message to public servants. On this date, public servants at all levels of government will receive notices affirming the fundamental principles of our Republic.

INSTRUCTIONS ON NOTICING PUBLIC SERVANTS:

By now, you should have prepared the notices you wish to send and chosen the public servants to whom you'll send them. If you haven't, please refer back to the instructions in the preparation stage of Phase 1. Today, April 24, 2024, marks "go day" – the day when people across America will unite and simultaneously mail these notices. In Phase 2, our voices will be heard, but for now, let's quietly deliver the message.

Copy and Mail Documents

- a. Make a copy of the original signed and witnessed "Lawful Notification of Corrective Action to Prevent Maladministration" for each recipient you have selected.
- b. Choose whether to either scan and email or mail **copies** to each person listed on the "Certificate of Service" page. Of course, you can do both and even choose to send by certified mail, but it is not necessary.
- c. Do not send the original signed document. Instead, keep it in a safe place along with a copy and all receipts for your records.

MEASUREMENT OF SUCCESS:

The goal of the Whisper Campaign is to have a minimum of 2.6 million people actively engage in putting their public servants on notice on April 24, 2024. This milestone will signify a significant shift in public awareness, indicating a renewed commitment to the principles of liberty and justice.

By following this strategy, we will reignite the beacon of liberty, thereby reinstating power to the people and returning them to their rightful position, as envisioned by our founding fathers.
